Again in the new school year, Cambria Heights School District is providing a protection plan for students and parents as part of our 1:1 device initiative. This plan covers accidental damage to a student's device and is designed to limit a family's financial responsibility for any damage as described in the coverage section below.

<p>DETERMINATION</p> <ul style="list-style-type: none"> ● The school administration, in consultation with the technicians and teachers who witnessed any damage, makes the final decision as to what is considered covered.
